ARTICLES OF INCORPORATION OF HARTINEZ GARCIA, INC.

The undersigned, for the purpose of forming a corporation FLORIDA under the Florida Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE 1

NAME

The name of the corporation is MARTINEZ GARCIA, INC., and the principal address is 3733 W.University Avenue, Gainesville, FL.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation may engage in, conduct or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV

CAPITAL STOCK
