ARTICLES OF INCORPORATION

OF

OCEAN MARINE SERVINES OF CANAVERAL, INC.



Article I - Name

The name of this corporation is OCEAN MARINE SERVICES OF CANAVERAL, INC., and its principal office is located at 399 Challenger Road, Cape Canaveral, Florida 32920.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.
