ARTICLES OF INCORPORATION

OF

CSI MANAGEMENT SERVICES ORGANIZATION, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is CSI MANAGEMENT SERVICES ORGANIZATION, INC.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

The Corporation may engage in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV: SUBCHAPTER "C" CORPORATION

The corporation elects to be organized as a Subchapter "C" Corporation in accordance with Internal Revenue Service designation.

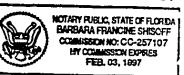
