

The undersigned, a natural person competent to contract, acting as incorporator of this corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is CARROLL MOTOR SPORTS, INC. (hereinafter called the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is 12734 Kenwood Lane, Suite 35, Fort Myers, Florida 33907.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for corporations organized under the General Corporation Act of the State of Florida.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is One Thousand (1000) shares of Common Stock, having a "\$1.00 par value" per share.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI

BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors.

The corporation shall have One (1) director initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.

The name and address of the initial director of this corporation is: TODD CARROLL, also known as James T. Carroll, 12734 Kenwood Lane, Suite 35, Fort Myers, Florida 33907.

ARTICLE VII

INDEMNIFICATION

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.

ARTICLE VIII

BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, but the board of directors may not alter, amend or repeal any bylaws adopted by majority vote of the shareholders if the shareholders provide that the bylaws shall not be altered, amended or repealed by the board of directors.

ARTICLE IX

AMENDMENT

These articles of incorporation may be amended at any time by a vote of the majority of the voting stock of the corporation outstanding, at any regular meeting of the stockholders or at any special meeting of the stockholders called for that purpose.




