ARTICLES OF INCORPORATION

Big Bend Pipeline & Terminal Company

THE UNDERSIGNED hereby executes and acknowledges these Articles of Incorporation in order to organize and incorporate a business for profit, under the corporate name and at the initial business address stated in Article VIII.

Article I- Purposes and Objects

The Corporation is formed pursuant to the specified laws of the State of Florida and for the purposes or objects stated in Article VIII. The Corporation may engage in the aforementioned business or specific profession and in any other transaction or business permitted under the laws of the United States and of the State of Florida.

Article II- Duration

The duration of the Corporation shall be perpetual. Corporate existence shall commence at the time stated in Article VIII, provided that all the requirements of the law are met.

Article III- Registered Agent and Office

The name of the Registered Agent and the street address of the Registered Office is stated in Article VIII.

Article IV- Number of Directors

The number of Directors, constituting the initial Board of Directors are stated in Article VIII. The number of the Board of Directors if any, shall be determined, from time to time, by the By-Laws.

Article V- Shares

The number of authorized shares, whether such shares shall be Par Value or No Par Value and the class of shares which are authorized are stated in Article VIII.
