ARTICLES OF INCORPORATION

OF

FLORIDA SITE DEVELOPERS, INC.

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

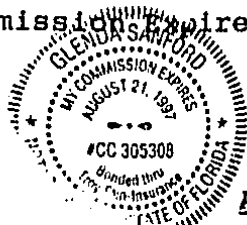
