ARTICLES OF INCORPORATION

OF

FLORIDA SITE DEVELOPERS, INC.

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be FLORIDA SITE DEVELOPERS, INC..

ARTICLE II

Principal Office

ARTICLE III

Corporate Purposes, Power and Rights
