#### ARTICLES OF INCORPORATION

OF

I, the undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, acting as incorporator of a comporation under the Florida General Comporation Act, do hereby adopt the following Articles of Incorporation for such comporation:

## ARTICLE I - Name and Address
