Articles of Incorporation
of

Article I - Name

The name of the corporation is: Nancy J. Visockis, P.A.

Article II - Duration

This corporation shall exist perpetually.

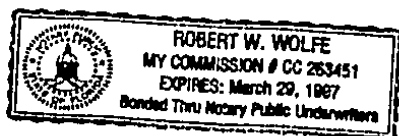
