# ARTICLES OF INCORPORATION

OF

SONE'S FLORALWORKS, CORP.

The undersigned, acting as incorporator of SONE'S FLORALWORKS, CORP. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of the corporation is:

SONE'S FLORALWORKS, CORP.

and the principal place of business is:

## ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

## ARTICLE III. PURPOSE

This corporation is formed for the purpose of engaging in the sale and distribution of floral products and in all businesses incidental thereto and may engage in any activity or business permitted under the laws of the United States and Florida.

### ARTICLE IV. AUTHORISED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

## ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 5200 Blue Lagoon Drive, Suite 700, Miami, FL 33126 and the name of the corporation's initial registered agent at that address is Miami Corporate Systems, Inc.

## ARTICLE VI. INITIAL BOARD OF DIRECTORS

#### ARTICLE VIII. BYLAWS

## ARTICLE IX. AMENDMENTS

These Articles may be amended prior to the issuance of shares of the corporation by the unanimous approval or consent of the board of directors. Thereafter, every amendment shall be approved by the board of directors, proposed by them to the shareholders, and approved at a shareholders' meeting by the holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.
