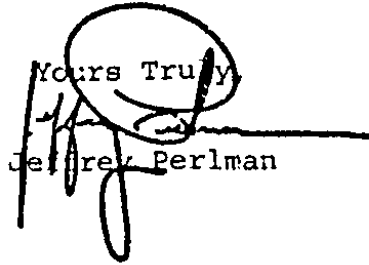

ARTICLES OF INCORPORATION  
OF  
Alayon & Perlman, P.A.

The undersigned, acting as incorporator, signs and adopts the following Articles of Incorporation for the purpose of forming a corporation under the Professional Service Corporation Act of the State of Florida.

ARTICLE I

The name of the corporation shall be: Alayon & Perlman, P.A.

ARTICLE II

The existence of the corporation shall commence upon the filing of these Articles of Incorporation by the Department of State and shall be perpetual.

ARTICLE III

The corporation is formed for the purpose of engaging in the business of providing legal services through attorneys licensed to practice law in the State of Florida and all related services, and in all businesses incidental thereto and may engage in any activity or business permitted under the Florida Professional Service Corporation Act. The corporation shall have all of the powers vested in a corporation organized under and existing by virtue of

such laws.

ARTICLE IV

The maximum number of shares of stock which the corporation is authorized to issue and have outstanding at any time shall be:

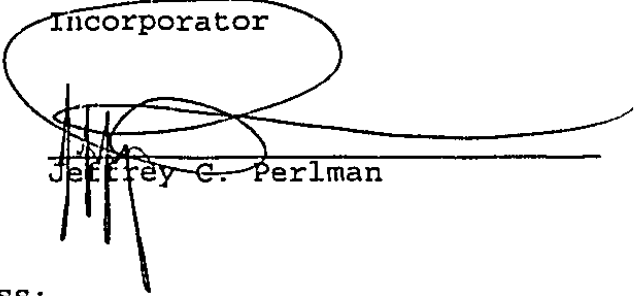

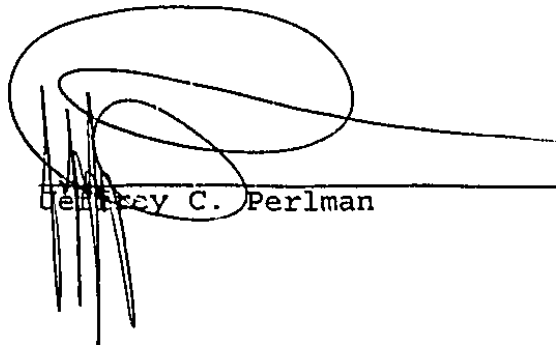
