ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS LA ROSA CENTER, INC.

DURATION



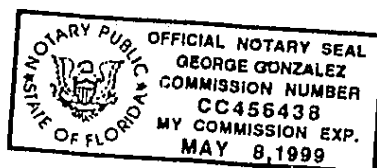


