ARTICLES OF INCORPORATION

SECRET
TALLAHASSEE, FLORIDA

WE, THE UNDERSIGNED, hereby associate ourselves together for the purposes of becoming a Corporation for profit under the laws of the State of Florida, and do hereby certify that we have become such Corporation under and pursuant to the following Articles of Incorporation:

ONE: The name of the Corporation is ALL AREAS COURIER/MESSENGER SERVICE, INC.

TWO: The principal office and mailing address of the corporation is:

2330 Croton Court
Pembroke Pines, Florida 33026

THREE: The Corporation shall have perpetual existence, unless sooner dissolved according to law. The date when corporate existence shall commence is upon the filing of these Articles of Incorporation by the Department of State, State of Florida.

FOUR: The general purpose for which this Corporation is initially organized and the general nature of the business to be transacted by said Corporation shall be and is as follows:

To engage in, transact and include the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, including the Florida General Corporation Act, as amended.

FIVE: The aggregate number of shares which this Corporation shall have authority to issue shall be a total
