NAME

INITIAL BOARD OF DIRECTORS

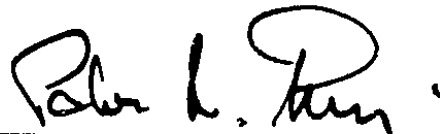
