

**ARTICLES OF INCORPORATION
OF
THE BASKET CONNECTION, INC.**

ARTICLE I - NAME

The name of this corporation is The Basket Connection, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting and engaging in any or all business permitted under the laws of the United States, the State of Florida and all other states, territories and jurisdictions of the United States.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of par value common stock which shall be designated "Common Shares" with a par value of Five Dollars (\$5.00) per share. This corporation may be designated as a Subchapter "S" corporation upon the timely filing of the appropriate forms.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his prorata share

thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
