## **Articles of Incorporation of PK, USA, INC**

### **ARTICLE I - Name of corporation :**

**The name of this corporation is :**

### **ARTICLE II - Duration:**

**This corporation shall have perpetual existence commencing on the date of this filing of those Articles with the Department of State,**

### **ARTICLE III - Purpose:**

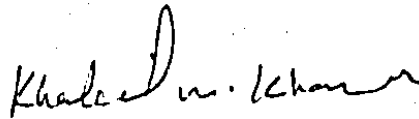
**Article IX - Indemnification :**

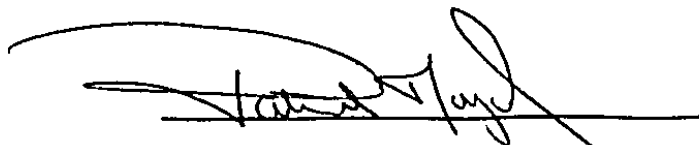

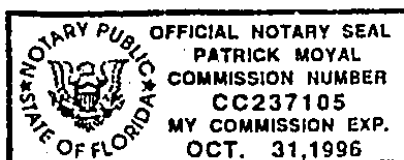
