Articles of Incorporation
of
Gateway Interactive Design Group, Inc.

The undersigned, for the purpose of forming a corporation under the Laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME

The name of the Corporation is:

Gateway Interactive Design Group, Inc.

ARTICLE 2 : DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE 3: PURPOSE

The Corporation may engage in any activities or business permitted under the laws of the United States and the State of Florida. The Corporation's specific purpose is the execution of advertising, marketing and promotional services, including consultation in and for the aforementioned markets, including all forms of mass communication — television, video, radio, print, signage, tele-marketing, etc.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

ARTICLE 4: CAPITAL STOCK

The total number of shares of capital stock authorized to be issued by the Corporation will be one thousand (1,000) shares having a par value of one dollar (\$1.00) per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.






