

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ADVANCED PROFESSIONAL SERVICES INC.

Pursuant to the provisions of §607.1003(6), Fla. Stat., the Florida Business Corporation Act, Advanced Professional Services Inc. does hereby amend its Articles of Incorporation as follows:

- 1. The name of the corporation is Advanced Professional Services Inc.
- 2. This Amendment to the Articles of Incorporation was duly approved and adopted on November 8, 1995, by a vote of the holders of all the issued and outstanding common stock of the Corporation being the only class of capital stock issued and outstanding and entitled to vote hereon, by written consent without a meeting, pursuant to §607.0704, Fla.
