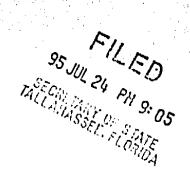

## **ARTICLES OF INCORPORATION** OF SEARLS APPLIANCE SERVICE, INC.

ARTICLE I. - NAME



The name of this corporation is Searls Appliance Service, incorporated.

#### **ARTICLE II. -DURATION**

This corporation shall exist into perpetuity.

#### Article III.-Purpose

This corporation is organized for the following purposes: to engage in sale and servicing of new and used appliances and for any other lawful corporate purpose.

#### **Article IV-Capital Stock and Voting Rights**

This corporation is authorized to issue 10,000 shares of common stock at \$1.00 par value, which shall be designated "Common Shares", and is authorized to issue initially 100 shares at \$1.00 par value, which shall be fully paid for at the time of incorporation. The, the initial capitalization of 100 shares shall be nonassessable.

This corporation snall initially have only one class of stock. Except as otherwise provided by law, the entire voting power for all purposes shall be vested exclusively in the holders of the outstanding shares.

#### **Article v.-Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purpose his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### Article VI.-Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 12945 Morris Bridge Road, Thonotosassa, Florida 33592 and the name of the initial registered agent of this corporation at that address is CHARLES GODWIN. #### Article VI.-No Directors

The corporation shall not have directors but the business shall be run by the shareholders.

#### Article XV. Amendments

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto; any right conferred upon the shareholders is subject to this reservation.

#### **Article XVI.-Powers**

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act, except this corporation shall not have the power to be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise.
