ARTICLES OF INCORPORATION

of

CURSAN ENTERPRISES INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of corporation shall be: **CURSAN ENTERPRISES INC.**

ARTICLE II - PRINCIPAL OFFICE

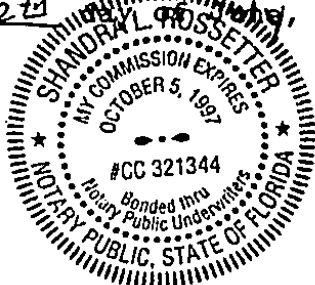

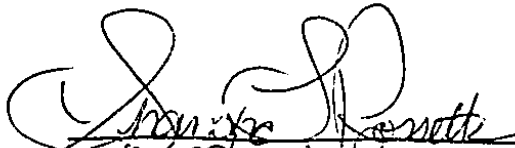
