ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act. Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name of the corporation is EASY AUTO SALES & FINANCE, INC., and its principal office & mailing address is 7202 E. Colonial Drive, Orlando, Florida 32807.

ARTICLE II. DURATION

The corporation shall have a perpetual existence.

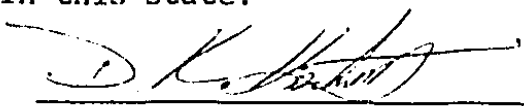

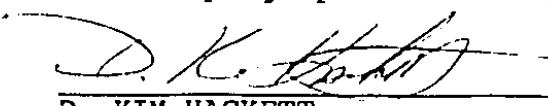
