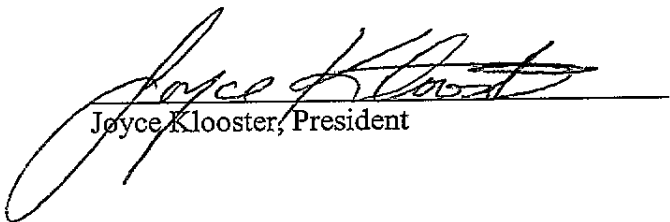

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

Article I. The name of the Corporation is: Gulf Coast Auto Glass Service, Inc.

Article II. The Board of Directors recommended to the Shareholders on December 18, 1998 that the Corporation be dissolved effective January 2, 1999, and a resolution to that effect was adopted by the shareholders of the Corporation on December 18, 1998, the number of votes cast or consents given for dissolution being sufficient for approval. Voting by voting groups was not required.

Article III. Pursuant to the aforementioned resolution, the effective date of the Articles of Dissolution and the date this Corporation is dissolved is January 2, 1998.
