ARTICLE I

NAME

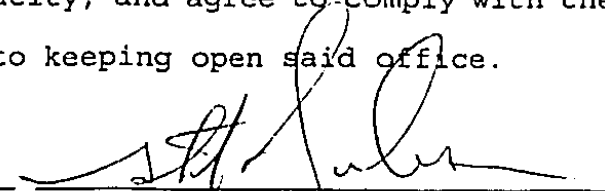

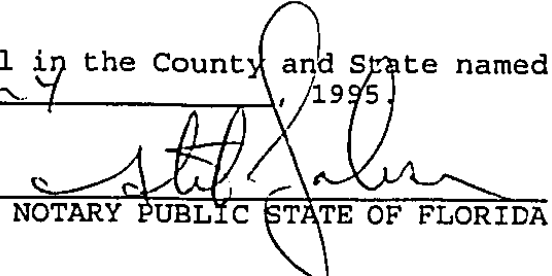
