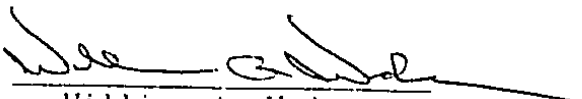

ARTICLES OF INCORPORATION

BILL & BRAD'S TROPICAL FORMULA INC.

We, the undersigned, make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida, for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation is, BILL & BRAD'S TROPICAL FORMULA INC.

ARTICLE II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United states, the State of Florida, or any other state, country, territory or nation.

ARTICLE III

The authorized capital stock of this corporation shall be one hundred (100) shares at one (\$1.00) dollar par value.

ARTICLE IV

The stock of this corporation is intended to qualify with the requirement of Section 1244 of the Internal Revenue Code and the regulations issued thereunder. Such actions as are necessary will be taken by the appropriate officers and officials to accomplish this compliance.

ARTICLE V

Management of the corporation shall be by the stockholders rather than a Board of Directors.

The amount of capital with which the corporation shall begin business shall be five hundred (\$500) dollars.

ARTICLE VII

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds shall have the right to purchase his prorata share thereof at the price at which it is offered to others.
