

ARTICLE I

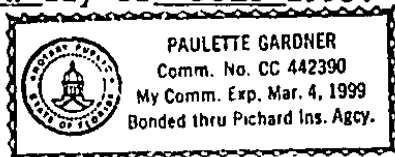
