

ARTICLES OF INCORPORATION OF

SEKWELL INTERNATIONAL IMPORT & EXPORT, INC. 2527 NORTH WEST 116 TERRACE CORAL SPRINGS, FLORIDA 33065

ARTICLE I

The name of the corporation is <u>SEKWELL INTERNATIONAL IMPORT</u> <u>& EXPORT, INC.</u>
