The name of the corporation is ALL CARIBBEAN SALES & SUPPLIES, INC.

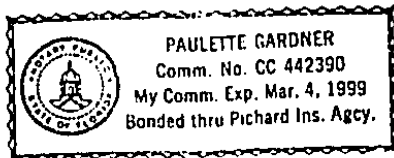
