ARTICLES OF INCORPORATION

OF

AL'S SERVICES & SALES CENTER, INC.

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, both residents of the State of Florida and being of full age has this day formed the corporation hereinafter described and hereby certifies:

ARTICLE I - NAME

The name of this Corporation is AL'S SERVICES & SALES CENTER, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office and the mailing address of the Corporation is 310 Old Country Club Road, Lake City, Florida 32025.

ARTICLE III - DURATION

The Corporation shall have perpetual existence.

ARTICLE IV - PURPOSE

The purpose of this Corporation is to engage in the business of the sale of used cars, motorcycles, lawn mowing equipment, tires, household appliances and small watercraft, including, but not limited to, maintenance, repairs, and the sale of parts and accessories for same, and to engage in any or all lawful activities or business.

ARTICLE V - CAPITAL STOCK

This Corporation is authorized to issue ONE (100) HUNDRED shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE VI - INITIAL REGISTERED
OFFICE AND AGENT

The initial registered office of the Corporation shall be 310 Old Country Club Road, Lake City, Florida 32025, and the initial registered agent of this Corporation at such office shall be ALVARO ALVARADO, who, upon accepting this designation agrees to comply with the provision of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

The initial Board of Directors shall consist of two (2) members. The number of directors may be increased or decreased from time to time as provided for by the By-Laws of the Corporation, but in no case shall the number of directors be less than two (2) nor more than five (5). 


