Article 1

Name, The name of this Corporation is NORTH CENTRAL FLORIDA MEDICAL SURGICAL ASSOCIATES, INC.

Article II

Principal Office: The principal place of business and mailing address of this corporation shall be: 7019 S.W. 11th Place, Gainesville, Florida, 32605.

Article III

Duration. The period of duration of this Corporation shall be perpetual.

Article IV

Purpose.
