**ARTICLES OF INCORPORATION
OF**

STORM PUBLICATIONS, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name: The name of the corporation is **Storm Publications, Inc.**

ARTICLE II

Duration: The corporation shall exist perpetually.

ARTICLE III

Purpose: The corporation is organized for the purposes of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

Capital Stock: The corporation is authorized to issue 1,000 shares of common stock having a par value of \$1.00 per share, all of which shall be common shares. The corporation is authorized to issue 1,000 shares of preferred stock.

ARTICLE V

Registered Office and Agent: The street address of the initial registered office of the corporation is 1800 Second Street, Suite 735, Sarasota, Florida 34236, and the name of the initial registered agent of the corporation at that address is Carl J. Robic, III.

ARTICLE VI

Principal Office: The principal office and the mailing address of the corporation

is 1616 Lake Shore Drive North, Sarasota, FL 34231.

ARTICLE VII

Board of Directors: The corporation shall have three directors initially. The number of directors may be increased or decreased from time to time by the bylaws, but shall never be less than one. The names and addresses of the initial directors of the corporation are:

Any person may hold two or more offices.

President and Treasurer shall be Christopher J. Parsons.


ARTICLE X


