

ARTICLES OF INCORPORATION

HERITAGE PROPERTIES OF DEFUNIAK SPRINGS, INC. 95 JUL 26 AM 9:26

ARTICLE I - NAME:

The name of this corporation is: HERITAGE PROPERTIES OF DEFUNIAK SPRINGS, INC., hereinafter referred to as the "Corporation")

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the historic property preservation business, and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

The Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PRE-EMPTIVE RIGHTS:

Every shareholder, upon the sale for cash of any new stock of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE-VI - INITIAL REGISTERED OFFICE AND AGENT:


ARTICLE IX - BY-LAWS:

ARTICLE X - SECTION 1244 STOCK:



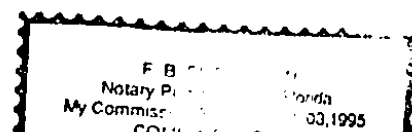
