The undersigned, for the purpose of forming a l corporation l under the Florida Business Corporation Act, adopt the following CRDA articles of incorporation:

#### ARTICLE ONE NAME

The name of the corporation is Worldwide Seafarers Cooperative Association, Inc.

#### ARTICLE TWO PRINCIPAL OFFICE


