Dear Ms. or Mr. Bailey,

Attached is a copy of a notice of the dissolution of my corporation, dated June 30, 1999. I am appealing this action for the following reasons:

- 1) This is the first notice that I have received of any kind from your office. I received no notice of prior dissolution. (The attached letter was dated 06/30/99 and did not reach me until 07/29/99.)
- 2) I mailed the check to your office on January 21, 1999. I then called your office in February and March, when the check did not clear my bank. The temporary address in Miami Lakes was on the form.
- 3) I sent your office a change of address when we moved from Longwood, Florida to Miami Lakes Florida, in November of 1998. Miami Lakes was a temporary address and I sent a second change of address when we moved to Pennsylvania in March 1999.
- 4) I twice called your office (early February and early March), when the check did not clear my bank. Both times, I offered to issue a new check but was told, "don't worry". Frankly, it did not occur to me to document those conversations.
- 5) I did not close that business checking account until March 17, 1999. As the account was closed, and all money moved to a new bank in Pennsylvania, I did not receive any notice from the bank that you had attempted to cash the check. I do not understand why it took more than two months to process the check.

In this case, I tried to do the right thing and mailed the filing fee when I first received the notice. I also notified your office of my changes of address. I am a one-person corporation and we hope to return to Florida, at some future date. I am not sure why the mail from you office was not forwarded to me. Please contact me at the numbers shown above, and thank you for your consideration.
