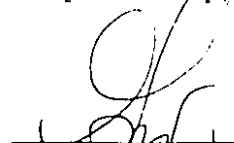

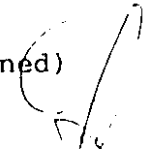
ARTICLE EIGHT
