

ARTICLES OF INCORPORATION
OF
VISION QUEST INVESTMENTS, INC.

ARTICLE I - NAME

The name of this Corporation is Vision Quest Investments, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 500 shares of common stock.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of 3 members. The number of directors may be increased or decreased from time to


time by vote of the stockholders, but in no case shall the number of directors be less than 2 nor more than 6. The names and addresses of the directors constituting the initial Board of Directors are:



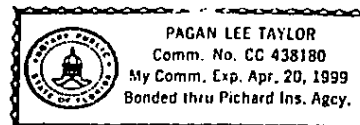
