ARTICLE I - NAME

The name of this corporation is Florida Flower Corporation.

ARTICLE II - ADDRESS

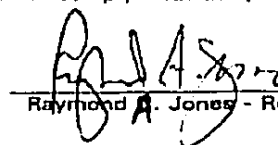
