


The purpose for which this corporation is formed is to conduct all lawful business authorized by the State of Florida and the laws of the United States, including, but not limited to the following:

The promotion and marketing of music and musical artists through the literary publishing of music industry publications and all rights related thereto, both for the corporation, and for third parties.


ARTICLE X




