

## ARTICLES OF INCORPORATION OF UNIWORLD HOLDINGS, INC.



### ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Uniworld Holdings, Inc., and the principal address and principal place of business is 18167 U.S. 19 North, Suite 150, Clearwater, Florida.
