ARTICLES OF INCORPORATION

KRIS COSMOPOLITAN, INC.

The undersigned subscriber(s) of these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME & ADDRESS

The name of the corporation is KRIS COSMOPOLITAN, INC. The corporation's principal office and mailing address shall be the same as the Registered Agent's office address.

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida and to effectuate such purposes, it may act in any capacity including as an agent or attorney-in-fact for any person or entity.

To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional services.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of common stock having a par value of ten cents (\$.10) per share.

ARTICLE V - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors, and for all other purposes, shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 265 Lee Avenue, Satellite Beach, FL 32937 and the name of the initial registered agent of this corporation at that address is KRIS SORNATALE.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

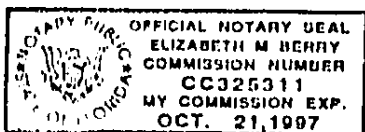
