ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is Renee Stouraitis, P.A.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting real estate transactions as permitted under the laws of the State of Florida and the United States of America.

ARTICLE III - CAPITAL STOCK

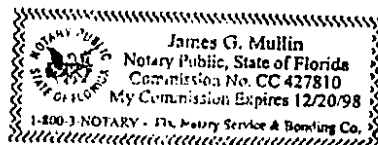
