ARTICLE I - Name of corporation:

The name of this corporation is :

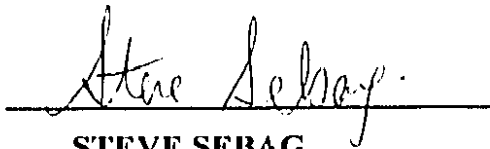
Article IX - Indemnification :
