

ARTICLES OF INCORPORATION

OF

SDS PROPERTIES INVESTOR GROUP, INC.

KNOW ALL MEN BY THESE PRESENT: That the undersigned incorporators do hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation

ARTICLE I

The name of the corporation shall be and is SDS PROPERTIES INVESTOR GROUP, INC.

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the date and time these Articles of Incorporation are filed with the Secretary of State.

ARTICLE III

The general purposes for which the corporation is initially organized are as follows:

(A) To transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.




