**ARTICLES OF INCORPORATION
OF
ORLANDO WALLPAPER STOP OF ALTAMONTE SPRINGS, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be ORLANDO WALLPAPER STOP OF ALTAMONTE SPRINGS, INC.

Article 2. Principal Officer. The principal place of business and the mailing address of this Corporation shall be 477 W. State Road 436, Altamonte Springs, FL 32714.

Article 3. Shares. The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$.10 per share.

Article 4. Initial Registered Agent and Street Address. The address of the initial Registered Agent of the Corporation is 4045 Kiawa Drive, Orlando, FL 32837 and the name of its initial Registered Agent at that address is Daniel E. Woodsby.

Article 5. Incorporators. The names and street addresses of the incorporators to these Articles of Incorporation are as follows: DANIEL E. WOODSBY, 4045 Kiawa Drive, Orlando, FL 32837 & LEISA B. WOODSBY, 4045 Kiawa Drive, Orlando, FL 32837.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is two. The number of Directors may be increased or decreased from time to time in accordance with the By-Laws, but shall never be less than one. The names and addresses of the initial Directors of the Corporation are as follows: DANIEL E. WOODSBY, 4045 Kiawa Drive, Orlando, FL 32837 & LEISA B. WOODSBY, 4045 Kiawa Drive, Orlando, FL 32837.

Article 7. Duration. The duration of the Corporation is perpetual.

Article 8. Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the Shareholders is subject to this reservation.

Article 9. Commencement of Corporate Existence. In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date upon filing of these Articles of Incorporation.

Article 10. Indemnification. The Corporation shall indemnify each Officer, including any former Officers, to the full extent permitted by law.

Article 11 Purpose The general purposes for which the Corporation is organized are the following

A To engage in and transact any lawful business for which corporation may be incorporated under the Florida Business Corporation Act No other purpose limits this general purpose in any way

B To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.


