ARTICLES OF INCORPORATION

QΕ

PREMIER USA CORP.

We, the undersigned, being the incorporators of Premier USA Corp., do hereby form a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, immunities and liabilities of incorporating for profit.

ARTICLE I

NAME OF CORPORATION
