The Articles of Incorporation of the undersigned corporation were originally filed on July 28, 1995, effective July 21, 1995, and assigned document number P95000058714. Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation (these "Articles of Amendment"):

1. The name of the corporation is Creative Catalog Concepts, Inc. (the "Corporation").
2. "Article I - Name." of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"Article I - Name and Address"

The name of this Corporation shall be MTD Worldwide, Inc. The mailing address shall be 1710 Timber Edge Drive, Deland, Florida 32724.

3. These Articles of Amendment were duly approved and unanimously adopted by the Board of Directors of the Corporation on October 4, 2005. The Board of Directors recommended approval of these Articles of Amendment to the Shareholders.

4. These Articles of Amendment were voted upon and duly approved, adopted, and ratified by all of the Shareholders of the Corporation on October 4, 2005.

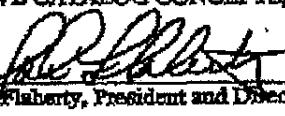
5. The number of votes cast for approval of these Articles of Amendment by the Shareholders was sufficient for approval.
