Articles of Incorporation of

United Promotions, Inc.

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation

- FIRST: The name of the corporation is United Promotions, Inc.
SECOND: The period of its duration is Perpetual
THIRD: The purposes for which the corporation is organized are fund raising for various charities and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 7,500 shares of common stock having a one dollar (\$1.00) of par value each.
FIFTH: The corporation will not commence business until at least one thousand (\$1,000.00) have been received by it as consideration for the issuance of shares
