#### ARTICLE I - NAME

The name of this corporation shall be TAMPA DIAGNOSTIC SERVICES. INC.

## ARTICLE II . NATURE OF BUSINESS

This corporation shall have a perpetual existence unless sooner dissolved by law.

## ARTICLE VI - PRINCIPAL OFFICE
