EARLY BYRD HOLDINGS, INC. EFFECTIVE DATE

Ing as Incorporate

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be EARLY BYRD HOLDINGS, INC. and the principal place of business shall be 4432 Edgewater Drive, Orlando, Florida 32804.
