ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is AUTOMATION SYSTEMS TECHNOLOGIES, INC.

ARTICLE II

The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE III

The corportaion shall have the authority to issue 100,000 shares of no par common stock, in one class only.

ARTICLE IV
