

THE UNDERSIGNED, acting as sole incorporator of DIAGNOSTIC CLINICAL LABORATORIES, INC. (hereinafter the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation (the "Articles") for the Corporation:

ARTICLE I Name

The name of the Corporation is: DIAGNOSTIC CLINICAL LABORATORIES, INC.

ARTICLE II Effective Date

These Articles are effective as of July 28, 1995, a date which is not more than five (5) business days prior to the date of filing, as provided for in §607.0203 of the Florida Statutes.

ARTICLE HI Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV Shares

The total number of shares which the Corporation shall have the authority to issue shall be Ten Million (10,000,000) shares, consisting of a single class of common stock having a par value of \$.15 per share.

ARTICLE V Preemptive Rights

No shareholder of the Corporation shall have any preferential or preemptive right to subscribe for or purchase from the Corporation any new or additional shares of

capital stock or securities convertible into shares of capital stock, of the Corporation, whether now or hereafter authorized.

ARTICLE VI Principal Office

The address of the Principal Office of the Corporation is 6320 St. Augustine Road, San Jose Commerce Center, Suite 9B, Jacksonville, Florida 32217. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the Corporation.

ARTICLE VII Mailing Address

ARTICLE VIII Initial Registered Office and Agent

ARTICLE IX Incorporator
